2. An Expert Team conducted on-site evaluation of the program during 7<sup>th</sup> to 8<sup>th</sup> October, 2017. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The program has been granted provisional accreditation for 2 years. **SDM Institute for Management Development, No.1, Chamundi Hill Road Siddharthanagar- Mysore- 570011, Karnataka** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above. It may require submission of pre-qualifiers before sending the Compliance Report for granting further accreditation.

The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **SDM Institute for Management Development, No.1, Chamundi Hill Road Siddharthanagar- Mysore- 570011, Karnataka** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is programme accreditation and not institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of program and the period of validity of accreditation, as well as the date from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
6. The accreditation status of the above program is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited program as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.
7. The accreditation status awarded to the program as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
