**Conditions:**

1. The Institution should obtain No Objection Certificate from the State University in the jurisdiction of which the institution is located.
2. The scholars and experts of the said institute should come and deliver lectures to the students of University of Mysore on request by the concerned department without TA/DA. However, such experts will be paid prescribed honorarium for the lecture they deliver.
3. They should extend academic interaction and co-operation with the faculty and scholars in the University of Mysore.
4. In the event of award of Scholarship/Research Fellowship by the said institute, the eligible post graduate students of our University shall be given preference.
5. The tenure of recognition and MoU is for a period of four academic years. However, the prescribed renewal fee shall be paid and acknowledgement be obtained within the prescribed period annually.
6. Annual Report about the progress of research work of the Institute should be submitted every year to the University.
7. The Doctoral Committee for Ph.D. students of Sri Dharmasthala Manjunatheshwara Research Centre for Management Studies, (SDMRCMS) SDMIMD, Siddarthanagar Post, Mysuru, should have at least one representative from the respective department of the University of Mysore.

8. In all publications made by the members of the faculty and research scholars/researchers of the institution, wherever the name of the institution is mentioned while citing the credentials of the author/authors, the following shall be mentioned i.e., "(A recognized research centre of University of Mysore)".
